We Further agree to protect, indemnify, save and hold harmless First Baptist Church, Mauriceville, Texas, its successors and assigns, and any employees or representatives, of and for any liability or damages which First Baptist Church, Mauriceville, Texas, may suffer as a result of claims, demands, causes of action, judgements, damages, injuries, debts and liabilities brought by third parties against First Baptist Church, Mauriceville, Texas, its successors and assigns, and any employees or representatives, and arising out of or in connection with out attorney's fees and other expenses which may be incurred by First Baptist Church, Mauriceville, Texas, its successors and assigns, and any employees or representatives, as a result of its defense of any such claims.

We further acknowledge that we have full power of authority to enter into this contract on behalf of our children and ourselves.
